GAGE PAPERS WARRANTS

The collection of warrants in the Gage Papers comprises an important segment of the financial record of the British Army in North America from 1763 to 1775. As commander in chief in North America, Thomas Gage had the responsibility to approve and authorize the army's considerable expenses there. The documents generated by this responsibility--Gage's archive of administrative financial records--form the collection of Gage warrants.

I. Definition of a warrant

The document whereby Gage specifically authorized payment for the army's expenses was a warrant. (See appendix for examples of types of documents cited in the text; superscript numbers refer to numbered appendix examples.) Following a standard form, a Gage warrant directed a deputy paymaster general to pay to an individual (civil or military), or to persons designated by the individual, a specified sum of money for particular expenses incurred by that individual on behalf of the army. The period during which the expenses were incurred is usually stated, and the warrant carries the date upon which it was issued. In the text of the warrant Gage acknowledges approval of accounts and vouchers verifying the expenses within and gives the location of these supporting documents (e.g., "as per the Annexed Account, the Vouchers for which are lodged in the [Gage's] Secretary's office"). Warrants were drawn up by Gage's secretary in triplicate; the signed, official copy was sent to the War Office in London; a copy was given to the payee named within; and another copy was retained by Gage. The warrants in this collection are those secretarial copies retained by Gage.

II. The two types of warrants in the collection

The collection consists of two types of warrants,

(A) those issued by Gage for the subsistence of the

army and (B) those for the extraordinary expenses of

the army.

A. Subsistence warrants

2

Subsistence warrants were granted for the regular pay and provision rations of the army. These warrants in the collection are arranged by the individual regiments for which they were issued and are contained in the first five volumes of the collection. Funds for subsistence were voted annually in Parliament in response to estimates submitted by Gage to the Paymaster General and the Secretary of War in London. These standard expenditures were then disbursed by Gage through warrants to the deputy paymaster general in North America, who transmitted the pay/rations to the regimental paymasters (who disbursed them to the troops). Gage sent the original wærrants to London and retained the secretarial copies. Generally, these warrants contain the number and cost of rations issued to a designated number of sargeants, corporals, drummers, and privates in each regiment for a specified period of time. Additional information is only rarely given; e.g., in a few warrants for the 1st Battalion, 60th Regiment, men who had been taken prisoner by Indians (listed by the mens' names, ranks, and lengths of captivity) and had been struck from the regiment's returns are compensated for subsistence due them.

B. Warrants for extraordinary expenses

The bulk of the collection (31 volumes) consists of warrants granted by Gage for the extraordinary expenses (also called "contingent" expenses) of the army. Because soldiers' clothing, medical care, and pensions were deducted from their pay (and therefore came under subsistence), the extraordinaries covered all other expenditures. These included, for example, certain military and civilian salaries and the expenses of the following: hospitals; victualling; frontier expeditions; the building and repair of fortifications, barracks, and boats; the transportation of men and stores; and disbursements to the Indians.

Because the warrants for extraordinaries are a greater potential source for research than the subsistence warrants, the remainder of this description deals with them.

III. The process of payment

Unlike the procedure for subsistence, Parliament approved sums for the extraordinaries only after these expenditures had been made in America. The disbursements

were made by the Paymaster General in London, from his running balance of the past year, to money contractors in England. These men were large merchant/"bankers" approved by the British government and granted contracts to ship specie to deputy paymasters general, assistant deputy paymasters, and to other contractors and agents in North America. All contractors and agents were civilians who were not employees of the army, per se, but who transacted business on the army's behalf. Contractors in America were merchants located in major cities who secured contracts with the army to supply goods, provisions, and the hire of vessels for military posts throughout the country. An agent might be a city merchant who held money and transacted business for a particular commanding officer. Local agents were usually shopkeepers located near the posts. In addition to supplying local inhabitants with sundry goods (bought on credit from city merchants), these local agents often transacted business between local inhabitants and the army and between the army and the city merchants/contractors.

Through this network of middlemen, money was paid (or credit extended) to men performing services or providing goods for the army. Their receipts for payment were submitted to Gage as vouchers, and Gage then issued a warrant for the amount, sending the original warrant to London for approval and retaining a copy for his records. However, this is a simplification of what was often a complex series

of transactions. Two examples, culled from the various documents in the collection of Gage warrants, may serve to illustrate the procedures involved. In the following examples the transactions begin not with the money contractors in London but with the man on the bottom level of the system.

EXAMPLE 1. James McGowdy, a farmer living outside Lancaster, Pa., is visited by a neighbor, who brings news from Lancaster. The neighbor has seen a public notice posted by the British Army, calling for volunteers to serve in defense of the forts west of Lancaster. McGowdy, his neighbor, and many other settlers decide to enlist as militiamen, and they are sent to Fort Ligonier. At the end of four months' service, McGowdy returns to his farm, carrying with him a written certificate signed by Lieutenant Blane which states that McGowdy was a militiaman at Fort Ligorier from June to September 1763. In April 1764, on notice of his officer, McGowdy endorses this certificate, attesting to the fact that he has received payment for the militia service therein described from the commanding officer, Colonel Bouquet. In fact, Bouquet has given McGowdy a signed document authorizing Bouquet's agent in Philadelphia to pay McGowdy or McGowdy's agent. Since McGowdy lives far from Philadelphia, he endorses this second document (a pay voucher4) and receives his money or credit

from a local storekeeper/agent. The local agent is then reimbursed by Bouquet's agent in Philadelphia.

These two documents, the endorsed certificate and pay voucher (both serving as "vouchers" in the language of the warrant), represent the lowest level of cash/credit exchange within the warrant collection. The next level proceeds with the exchange between Bouquet and the Philadelphia agent, whom Bouquet has designated to keep his accounts. Bouquet secures from the agent the accumulation of pay vouchers such as that given McGowdy, representing the total expenses of the militia serving at Fort Ligonier in 1763. To facilitate accounting, Bouquet has a list drawn up with the names of all the militiamen, the dates of their service, and their wages. This list, or pay bill, 5 is entered in turn on a large account 6 which includes other types of expenditures Bouquet has made on his expedition to the west in 1763 and 1764. He submits to Gage all of the vouchers, the pay bill listing the vouchers, and large account listing all of Bouquet's expenditures. Gage's secretary then makes a brief abstract of the account and annexes it to the warrant which Gage issues in 1765 to the deputy paymaster general, directing him to pay to Bouquet (or agents designated by Bouquet) the amount of Bouquet's expenses in 1763 and 1764. The official copy of the warrant is sent to London; another copy is given to Bouquet (or to his designated agents); and a copy is retained by Gage.

EXAMPLE 2. Jacob Harsin, one of many gunsmiths living in Mobile, West Florida, is hired by the British army to repair the guns of an Indian tribe near Mobile. Upon completion of his service to the Indians, he receives a certificate from an army officer attesting to the time served and the wages owed him. He redeems the certificate with local agents, who apply to John Stuart, superintendent of Indian affairs in the South, for reimbursement. Stuart draws a bill of exchange (a draft for payment) upon Gage, in favor of the agents. The bill is a standard form which designates the time at which payment is to be made and for what purpose ("mending, cleaning, and repairing the Indian arms &ca. at Mobille"). Stuart's secretary makes out the bill of exchange in triplicate; one copy is retained by the agents and the other two are submitted to Gage, along with the gunsmith Harsin's voucher (i.e., his endorsed certificate), and those of other gunsmiths who have worked in Mobile. After examining the vouchers, Gage's secretary signs the bill of exchange "accepted," thereby assuming responsibility for payment. At the specified time, Gage's secretary pays the agents, who endorse the bill of exchange as well as a covering bill of exchange receipt, which the secretary has made up to accompany the bill of exchange and to facilitate its further transmission. The secretary then adds this bill of exchange to many others drawn by Stuart, and to additional bills drawn upon Gage by other officers commanding in the South. A warrant is subsequently issued by Gage (authorizing payment to his secretary, who has accepted and paid the bills) for the amount of expenditures represented by the bills of exchange. A <u>list of the bills drawn</u> with dates of the bills, when they were paid, and other particulars, is annexed to the warrant. The original warrant, with a copy of each bill of exchange and its covering receipt, is sent to London. Gage retains a copy of the warrant, and copies of the bills of exchange and their covering receipts.

IV. Types of documents in the collection

The preceding discussion illustrated the way in which the warrants and their accompanying documents were used to effect the army's financial transactions. In the following outline, those documents already cited will be further defined, and several other types of documents which may accompany warrants in the collection will be mentioned.

A. Warrant¹

A document issued by Gage authorizing payment to individuals for army expenses.

1. Temporary warrant la

After 1770 Gage occasionally issued a temporary warrant, which advanced sums of money to enable a commander of an army department (e.g., the barracks master general) to carry on

services in the department. A temporary warrant assumed that an accounting of the expenditures for which this money was advanced would accompany a later warrant.

B. Accounts

These may be <u>annexed accounts</u>⁶, i.e., affixed to the warrants either on a sheet sewn into the folded warrant, or they may accompany the warrant separately (unattached). In either case, the accounts are detailed lists of expenditures, usually lists of the vouchers for those expenditures. If the vouchers have been numbered on their reverse sides, the account will usually list the vouchers in numerical order.

Accounts provide nearly the equivalent detail given on the vouchers, except for the names and signatures of any agents involved.

1. List of bills of exchange drawn 10

Essentially, a list of bills drawn, as in Example 2 above, is also an account, because it is a list of expenditures. The level of detail given on the list is often dependent on the existence of vouchers (see bill of exchange in following section); the list of bills drawn does provide information on the bills, such as date, by whom drawn, in whose favor, and for what amounts.

2. Signed account 6a

Sometimes annexed accounts are signed by a commanding officer and/or the principal agent or contractor. A signed

account may often be an authorization by the individual to whom the warrant has been issued to transfer the payment of the warrant to an agent or contractor. In this case, the account becomes more than a mere list of expenditures--it serves as a negotiable receipt.

3. Abstract of an account 7

This is simply an abstract of a larger account. It may be annexed to a warrant or separate.

4. Account current 11

This is an annexed account that lists sums previously paid in addition to sums for which the particular warrant has been issued. An account current is thus a reckoning of the payee's present account with the deputy paymaster general.

C. Vouchers

Basically, a voucher is any receipt showing payment, such as an endorsed <u>certificate</u>³ or <u>pay voucher</u>. However, since warrants were granted for such a variety of expenses, the types of documents that serve as vouchers in the collection are diverse.

1. Bill of lading 12

This document may accompany a warrant in which the transport of men or goods by watercraft constitutes an expense, as in the hire of a schooner. Usually given within bills of lading are the names of the vessel, its master,

perhaps its owner or the contractor who hired the vessel for the army's use, and the rate of commission charged, costs involved, goods shipped, etc.

2. Roll or pay bill

The pay bill noted in Example 1 above is not actually a voucher since the pay vouchers listed on it also accompany the warrant. However, where the individual vouchers are not included, a roll 13 listing the men employed, for what period, their occupations and wages, and their signatures may serve as a voucher.

3. Invoice or bill of goods 15

For example, an innkeeper's bill or an invoice of sundry articles sold by a merchant may serve as vouchers. Perhaps it should be mentioned here that a bill or invoice of this sort occasionally is termed an account, such as "Mr. Smith's acct." However, Mr. Smith's account is considered a voucher and it would be listed on an account annexed to a warrant. It is only in the latter sense of the word, and as explained in the section 'B. Accounts' above, that the term "account" is used in this discussion.

D. Bill of exchange

As described previously in Example 2, a bill of exchange is drawn by one party upon another to pay a certain sum to another designated party. The time at which payment is to be made and the reason for the expenditure are

specified. The bill is signed "accepted" by the party upon whom it is drawn and endorsed on the reverse by the party to whom payment is made. It is also signed by the party who draws the bill in the first place.

Bills of exchange in this collection are usually drawn by commanding officers in favor of principal agents or contractors. Therefore, they provide detail for a higher level of financial transaction than do vouchers of a simple nature. When no vouchers accompany a bill of exchange, the reason for expenditure is usually given on the bill as "for expenses in the department." However, when a voucher accompanies a bill of exchange, there is more detail on the bill; the reason for expenditure would be more specific, e.g. "for Joseph Simon's services as interpreter to the Indians."

Bills of exchange may be hand-written or <u>printed</u>

1. Bill of exchange receipt

This document accompanies a bill of exchange. It gives particulars of the bill and is signed by the party to whom payment of the bill is made.

E. Miscellaneous documents

In addition to the more standard forms outlined above, the collection contains a variety of documents of a less official financial nature. These serve primarily

as certificates, which accompany warrants to prove service or to certify that an expense has been contracted if not in fact paid for.

1. Memorial 16

This is a statement made and signed by an individual certifying that he has rendered a particular service.

Usually no other supporting documents are found when a memorial accompanies a warrant. Nearly all the memorials in the collection are annexed to warrants.

2. <u>Legal documents</u> 17-18

These may be depositions (testimonies), agreements, contracts, or any witnessed/sworn statements.

3. <u>Discharges</u> 19-20

Discharges are documents that release from service either a person serving as a volunteer in the army or a private vessel that has been hired by the army.

4. <u>Wrappers</u>²¹⁻²²

These are not documents at all, merely papers used to wrap documents in the collection for ordering and storing. Written on the wrappers are notations of their contents, e.g. "Warrants for January 1765."

Whether or not a given warrant will be accompanied by one or more of the above documents depends on several factors. A warrant for a very routine, simple expense, e.g. the salary of Gage's secretary, may have no accompanying data.

A warrant for the salary of another official may have only an annexed memorial. Yet, on a complex level, a warrant for the expenses of a particular army department may have an account, bills of exchange, receipts of bills of exchange, and numerous types of vouchers.

In many cases, the warrants have annexed accounts, but no vouchers. Usually this is because the vouchers were not submitted to Gage as proof of expenditures, but remained lodged with a subordinate commanding officer (the deputy quartermaster general, e.g.). In these cases, Gage granted warrants on the basis of the accounts submitted by the officers. But if the vouchers were submitted to Gage, they usually accompany the warrant (except in cases where they have been lost).

Clearly, then, the greater number of documents accompanying a warrant, the greater the detail provided. It is because so many of these documents are contained in the collection that the Gage warrants offer such a wealth of data on the British Army in North America for this period.

V. Problems in the cash/credit financial system

All of the documents in the Gage warrants, although couched in terms of "pay" or "paid" in sums of pounds sterling and New York, Philadelphia, or sometimes French currency, are essentially steps in a vast, tangled system

of credit. Certainly money did change hands here and there along the way. But as often as not, it was in fact the money value of the document which was exchanged. Even in the case of militiaman McGowdy (in Example 1 above) it is probable that his local agent/storekeeper merely applied the value of McGowdy's pay voucher to McGowdy's outstanding account of goods which the agent had sold McGowdy on credit. Or, the agent may have been short of specie and given McGowdy a promissory note for the pay voucher. One way or another, the agent exacted a commission for his service of redeeming the voucher in far-off Philadelphia. Commissions and rates of exchange entered into each transaction; however, these are not usually stated on the documents in the collection.

The problems involved in transporting cash to distant military posts were of major proportion. Hence, the extensive use of credit on the frontier. However, a more basic difficulty was maintaining adequate specie (shipped by the London money contractors) in the "military chests" of the deputy paymaster at headquarters and in the hands of colonial agents, so it could be transported to local agents and assistant deputy paymasters at the posts. When this supply of specie was known to be low, rates of exchange on the army's bills of exchange in America rose sharply.

Late in 1765 Parliament (dissatisfied with the large sums paid for extraordinary expenses) attempted to impose economic measures to reduce the cost of maintainingthe army in America. Parliament insisted that extraordinary expenses were to be kept to a minimum. It directed the various commanding officers in North America to spend money only in cases of emergency. Parliament then eliminated the London money contractors who had formerly supplied specie to North America. Also eliminated was Gage's role in the transactions of bills of exchange. When an emergency occurred, a commanding officer was to draw a bill of exchange directly upon the Treasury in London.

For this reason there are only four warrants in the collection for 1766 and very few for early 1767. But, because extraordinaries rarely constituted emergencies, the army in America necessarily continued to make expenditures. Gage and other officers were forced to borrow money to meet contingent expenses in some cases. By mid 1767 deficits, bad credit, high rates of exchange on the Treasury bills in America, and the general unwieldiness of this system finally forced a return to the traditional system of London money contractors and bills drawn upon Gage for the disbursement of funds.

Another feature of the cash/credit financial transactions for extraordinaries was the sluggishness with which they were brought to completion. As noted earlier, the warrant which covered the pay of militia at Fort Eigonier in 1763 was not issued until 1765. And then, of course, authorization of the expenditures was not official until the warrant reached London and Parliament chose to approve the funds (usually a year or more later). Because of the difficulties of transport and the complexities of the financial network, most warrants represent at the least a six-month time lag from expenditure to warrant. An extreme case is the warrant which Gage finally issued in 1771 to pay the wages of an Indian agent for services rendered in 1764!

VI. Types of warrants for extraordinary expenses

The warrants issued for extraordinaries fall into certain broad categories: (A) salary warrants, (B) district and departmental warrants, and (C) miscellaneous warrants. Between these categories, however, there is considerable overlapping, which will be noted in the following discussion of each type.

A. Salary warrants

These were issued at fairly regular intervals, usually every year or six months. They have no accompanying documents except memorials and give little information beyond the specified salary for individual military and

civil employees. Among those to whom Gage granted these warrants were his secretary; the director of the general hospital (and surgeons, physicians, and hospital officers); storekeepers at large garrisons; the superintendents of Indian affairs in the northern and southern districts; the signal man at Castle William in Boston; and two civilians in charge of supervising transport at Fort Stanwix and Fort Ontario (no longer active military posts, but located near a portage and lake port, respectively).

However, one cannot find all of the surgeons' and store-keepers' earnings in North America, e.g., in these individual salary warrants alone. Regimental surgeons and store-keepers who were not salaried (i.e., who earned wages only) were often listed in the expenses of district and departmental warrants.

B. District and departmental warrants

District warrants were those granted for the expenses in the two geographical jurisdictions of the army in North America: (1) northern and (2) southern. Departmental warrants were issued to administrative divisions of the army. These included the departments of (3) Indian affairs in the northern district, (4) Indian affairs in the southern district, (5) the deputy quartermaster general, (6) the barracks master general, (7) the commissary general of stores and provisions, (8) the engineers, (9) the commissary

of musters, (10) the postmaster, and (11) hospitals.

Unlike salary warrants, those for districts and departments are more complex and provide a much richer source of data. Hence they are treated here more fully.

There is much overlapping between the district and departmental warrants. The most frequent form of overlapping is as follows. Because most of the army departments had certain jurisdictional limits, some departmental expenses were included in district warrants. For example, since the Department of Engineers maintained staff commands only at Halifax, Boston, and Pensacola, engineers' expenses at a remote Canadian post were included with a warrant for expenditures of the northern district.

But despite intricacies and qualifications, certain characteristics did apply to both district and departmental warrants, about which generalizations can be made. They were not issued with any particular degree of regularity since the considerable expenditures of the districts and departments varied throughout each year.

Vouchers do not usually accompany these warrants because they were not submitted to Gage, but retained by the commanding officers of the districts and departments. But these warrants do have annexed accounts that provide much detail.

Expenses common to both districts and departments were rent and firewood for offices, clerks' and assistants' wages,

and stationary supplies. Other standard expenditures included the wages of artificers and laborers of all kinds for repair of boats, storehouses, furniture, etc.; materials and tools (shovels, lumber, nails, etc.) for repairs; and rent of storehouses and the hire of guards Also entered on the accounts were the purchase of sundry goods (brass kettles, tar, fabric for medals, rum and whisky, hides, garden seeds, fish hooks, rope and twine, mosquito nets, camp colors, needles and thread, etc.) and the costs of various services (digging drains, sweeping chimneys, guarding the wood pile, renting a house or yard, hauling rubbish, etc.).

The individual districts and departments and their particular expenses are described below.

- 1. Northern military district
- 2. Southern military district

These geographical areas were not properly speaking the northern and southern halves of the country. The northern district consisted chiefly of the province of Canada. The southern district was the combined southern province of East and West Florida and all outposts in western areas (i.e., western Pennsylvania, Michigan, the Great Lakes, Illinois, etc.). The expenses at Boston and New York were treated by warrants independent of the two districts.

Two brigadier generals commanded the districts and were issued warrants for the districts' expenses. Expen-

ditures in these warrants often included costs of legal duties for which the brigadiers were responsible, e.g., courts-martial and the hire of executioners. District warrants routinely encompassed the expenses of the various posts within each district. A southern district warrant would include expenses for Fort Chartres, Fort Pitt, Michilimackinac, Lake Ontario, Pensacola, St. Augustine, Mobile, etc.

However, there are also warrants in the collection granted specifically to commanding officers at the various posts. For example, a warrant was granted to the commander on the Great Lakes for sails and rigging lost in a storm. Hence, expenses for a given post are not found solely in the warrant for the district in which the post lies.

The northern district warrants invariably contain detailed annexed accounts and no other documents. Warrants for the southern district are usually accompanied by bills of exchange and their receipts drawn by the brigadier in the southern district and by commanders at the posts. The latter are often also accompanied by vouchers.

3. Indian affairs in the northern district

Those warrants granted to the superintendent of Indian affairs in the northern district contain lengthy annexed accounts which detail disbursements to Indians and provide the names of chiefs and tribes, with explicit reasons for

the outlays. Expenses included provisions for Indians with small pox; coffins, burials, and condolences; intelligence brought to the superintendent; printing and binding Indian prayer books and bibles; etc. Among the gifts to the Indians were taffeta ribbons, gartering, knives of all sorts; jacket buttons, large bells, India callicoes, scissors, combs, checked and ruffled shirts, razors, guns, flints, powder, and jappaned looking glasses.

Also included were wages of gunsmiths, interpreters, clerks, and Indian agents; and the expenses of various persons traveling within the district on Indian business. The costs of meetings held to settle treaties included the amount and kind of food and drink consumed, lodgings and entertainment, and damage to local property sustained by the great number of Indians assembled.

4. Indian affairs in the southern district

The warrants granted to the superintendent of Indian affairs in the southern district are found combined with those issued to the brigadier general of the southern district. That is, both the superintendent and brigadier general are cited within the text of the warrants themselves issued to cover the expenses of both department and district.

These warrants are almost invariably accompanied by an annexed list of bills drawn, along with the bills of exchange and receipts. Neither the superintendent's nor the brigadier

general's bills are accompanied by vouchers. But the warrants do include bills of exchange drawn by subordinate officers at posts within the district (some drawn for expenses in the department of Indian affairs, some for expenses of the post generally), and these bills are often accompanied by vouchers.

5. Department of the deputy quartermaster general

This department was primarily responsible for the transportation of men and goods throughout North America. Few vouchers accompany the warrants, but annexed accounts provide detail for the following type of expenses: marching of troops (places of arrival and departure and those regiments transported are given); transport of stores and provisions; freight of vessels; procurement, building, and repair of carts, wagons, and boats; drivers' wages; insurance of goods shipped as presents to the Indians; purchase of oars, paddles, and poles; etc.

Some warrants were issued to cover expenses for this department throughout North America, while others were granted for the specific expenses of a deputy quartermaster general at one post, e.g. Halifax.

6. Department of the barracks master general

This department was primarily responsible for the lodging of soldiers and officers throughout North America. Few vouchers accompany the warrants, but annexed accounts

provide detail for the following type of expenses:

officers' lodging money; repairs of barracks; purchase

of cooking utensils, straw to fill bedding and bolsters,

and fuel, candles, and furniture for barracks. Also

given are specifications of barracks, e.g., space alotted

per soldier or officer and fuel, etc., alotted to each.

7. Commissary of stores and provisions

This department was primarily responsible for victualling the troops throughout North America. Few vouchers accompany the warrants but annexed accounts provide detail for the following type of expenses: wages of coopers and laborers in the commissaries and of provision inspectors; letting contracts to victuallers; purchase of scales, weights and measures, kegs and barrels; etc. Also given are names of vessels employed for transporting provisions (with places of arrival and departure and dates) and the specific provisions shipped (flour, peas, pork, etc.) given either by weight in pounds or by numbers of rations.

Some warrants were issued to cover the department's expenses at various posts throughout North America. For certain posts, e.g., Detroit, there are warrants granted to the specific contractor who provisioned the post. In this type of warrant, the annexed account is usually certified by the signature of the commissary of stores and provisions.

8. Department of engineers

This department was primarily responsible for munitions and fortifications throughout North America. Few vouchers accompany the warrants, but annexed accounts provide detail for the following type of expenses: construction of barracks, hospitals, prisons, magazines, guard rooms, pumps and wells, grates and cranes, coal boxes, births and cradles, racks for arms, coal, and wood yards; surveyors' bills and wages; payment of building contracts; wages for carpenters, quarriers, smiths, masons; laborers' pay to turf magazine entrances and to screen and air gun powder; purchase of glass, paint, door and window hinges, facines, lime, bricks, shingles; etc.

Some warrants were issued to cover expenses for this department throughout North America; others were granted for the specific expenses of a commanding engineer at a particular post such as Boston.

Users of the collection should be aware that the department of engineers was administered in London by the Board of Ordnance, a branch separate from the army and the War Office. Funds for the engineers were voted not by Parliament, but by the king, the privy council, and the secretaries of state. Nonetheless, payments for the department's subsistence and extraordinary expenses were disbursed by Gage's warrants to the deputy paymaster general.

9. Commissary of musters

Warrants were issued to the commissary of musters for carriages, horses, guides, etc. required for mustering troops in North America for approximately six-month periods. Annexed accounts outline trips, e.g. from Albany to Michilimackinac, giving the number of miles between various posts--going and returning--with the cost for each leg of the journey.

10. Department of the postmaster

Warrants were issued to the postmaster for the expenses of maintaining a regular post between New York City and Albany, Philadelphia, Boston, etc. There are no vouchers but annexed accounts include annual costs of riders' salaries, Boston and Philadelphia newspapers, letters sent to individual commanding officers, etc.

11. Department of hospitals

Warrants were granted to the director of the general hospital in New York for the expenses in the department, and occasionally to a chief surgeon for expenses in a hospital such as at Boston. Vouchers accompanying the warrants give individual costs for stores (oatmeal, madeira and port, limes and lemons, soap, vinegar, brooms, cooperware, scissors, tea water, bottles, etc.) and for services (lettering medicine chests, washing shop towels, carriage

of chests, repair of packing cases, nurse's pay, etc.).

There is also a warrant for the fitting out of a hospital in the West Indies; vouchers include itemized invoices of chemicals and surgical instruments, in addition to expenses similar to the preceding.

C. Miscellaneous warrants

In addition to the warrants which fall into the categories broken down above are warrants which exist for more specific expenses. Separate warrants were granted when a schooner was hired for transport, when arrears in pay were settled, when an expedition was sent out, when a new company was recruited, and when a troop detachment was sent on special assignment. There are also individual warrants for victual contractors of certain posts; for forage money of officers; for the subsistence of temporary independent companies and of invalids who were recommended for veteran retirement but who had not yet left America; for courts of inquiry, etc.

VII. Notes to users of the collection

Certain cautions should be observed by readers using the collection. Two of these are here reiterated: (1) Data on any one topic is spread widely throughout the collection.

(2) The warrants, accounts, and bills of exchange found herein are Gage's secrearial copies (although these may be

considered entirely accurate copies).

In addition, it should be remembered that there are some gaps in the collection. The scarcity of material for 1766 and early 1767 has already been mentioned. Some warrants, vouchers in a series, and other documents which were obviously in existence at one time are lacking, no doubt through simple loss. Missing data such as the vouchers that were lodged with commanding officers other than Gage could possibly be located by the reader in the papers of these officers, if the papers exist.

To make full use of this collection, readers should also consult: the Commons Journal (source of army estimates and annual figures for expenditures); correspondence in the Gage Papers, especially that between Gage and the Treasury and War Office; accounts in the Gage Papers, wherein are found miscellaneous materials relating to provisions, contractors, and the Treasury. In order to gain a complete appreciation of the strengths and limitations of this collection, the reader would ideally examine contemporary military accounts in the British Public Record Office.

Finally, use of the inventory is essential for the location of particular areas of research in the collection.

The warrants are arranged chronologically within the volumes by date of warrant.
